Key Result of CRA Analysis:

Forest owners saw a 86% reduction in taxation on harvested timber between the 1980-1985 five year period and the 2011-2016 five year period. The lack of meaningful taxation continues to this day. The reduction in forest harvest taxes benefits one primary group: wealthy U.S. and foreign investors who extract yearly profits from Coast Range and Western Oregon private forests.
