



Coast Range Association Releases Green New Deal Proposal for Private Industrial Forests

Read the Proposal

Today, the Cost Range Association released (CRA) groundbreaking Climate Oregon's Industrial Forests: A Green New Deal Proposal. The proposal responds to a call by Congressional leaders for proposals related to the Green New Deal (GND) framework of House Resolution 109. Our proposal calls for vastly increasing stored forest carbon on corporateindustrial forests providing social benefits to forest workers and rural communities.

No similar proposal exists for industrial forestlands that scales to the climate emergency and concurrently achieves the just transition goals of the GND.



Our GND work is grounded in a critical analysis of the large investment-based timber corporations that dominate Western Oregon's most productive private forests. The GND proposal is based on two initiatives: land reform through a GND financed buyout of current industrial forest owners and the transfer of purchased lands to locally owned and managed social benefit businesses and


organizations.

The GND is based on the legacy of the Roosevelt era New Deal. We realized one solution was right before our eyes. Across rural Oregon electric power, telephone and internet services are often provided by locally owned and managed cooperatives. They provided a key model for new forest ownership.


Going forward we will distribute the proposal and brief key GND leaders in Congress and grassroots partners across the country. With your support this vision will spread far and wide.

Breaking News:

In an unexpectedly dramatic move, the Fish and Wildlife Service has excluded 3,472,064 acres, mostly in Oregon, from the northern spotted owl's critical habitat designated under the Endangered Species Act. The

final amount soared well beyond the 204,653 acres proposed for exclusion in August, 2020.

CRA is following the situation and will send updates as more information becomes available.
